Meeting Called to Order at 6:40 by Suzanne Sabin.

<u>Amendment to Bylaws.</u> Suzanne Sabin reported that a clause in the Bylaws is obsolete, namely, the following language in paragraph c of Article IX, Section 1: "and the current meeting location for such meetings is the Tucson Pastel Society, 2447 N. Los Altos Ave." She recommended such clause be deleted. Upon motion and second, the proposed amendment was unanimously approved by the membership.
